- 6 Hopefully we will underspend this, but the lawsuits aren't over until they are over. The Tort lawsuit is over.
- 7 We failed last time to get the County to take over the Forest Service easement. We continue to try. There is also a BLM easement on the East side.
- 8 We need to move our gravel stockpile in the National Forest. We secured permission from the County to use part of their space. The Burn Pile cannot remain with the current ruling.
