## **Meeting Minutes:**

After email notice to all residents of HRSID pursuant to Wyoming Statute 16-4-404, the Board of Directors of Hoback Ranches SID held a special meeting at 11:00 AM on Thursday, January 16, 2025, in the parking lot at the intersection of Rim Road and Skyline Drive.

This meeting was to inform residents of the upcoming Commissioners Meeting on 1/22/25 at 9 AM, where Sam Sumrall would present a formal request for Sublette County to take over maintenance, plowing, etc. of the first 3 miles of Rim Rd. from the highway to the HR Arch.

This Special Meeting was held in the Skyline Drive Parking Lot with about 12 residents attended, including Board Members, Sam Sumrall & Bill Balderston. Sam outlined the history of the 1<sup>st</sup> 3 Miles and HRSID's interest in having Sublette County take over responsibility for the road. History dates back years and previous Boards have been pursuing this action but for many different reasons have not been successful. Sam feels this time we have a very good chance of getting the County and Forest Service to agree.

If successful, this will free up budget funds to dedicate to other internal HRSID Road needs (ie. Guard rails, culverts, proper crowns on roads for drainage etc.)

Commissioners Meeting will be held at the town hall on 1/22/25 at 9 AM. Sam anticipates knowing the results of Commissioners decision during this meeting and will update HRSID residents via email of the results.

The Special Meeting was adjourned at 11:45 AM.
